

End User License Agreement

(EULA) – Corporate License (Level 3)

Please read this agreement carefully before installing the Font Software.

1. GRANT OF LICENSE

Eurotypo (hereinafter “Licensor”) grants the purchaser (hereinafter “Licensee”) a non-exclusive, perpetual, non-transferable, and worldwide license to install and use the Font Software (hereinafter “the Font”) subject to the strict terms and conditions set forth in this agreement.

By downloading or installing the Font, you acknowledge that you have read, understood, and agreed to be bound by the terms of this agreement. You are purchasing the right to use the Font (a license), not ownership of the design or the copyright.

This **Corporate License** allows for unrestricted use within the Licensee’s organization, designed for large enterprises and global brands.

2. UNLIMITED USERS AND ORGANIZATION

- **User Limit:** This license covers an **UNLIMITED number of Users (CPUs)** owned by the Licensee.
- **Scope:** Coverage applies to the single legal entity (company or organization) purchasing the license and its direct employees worldwide.
- **Server Installation:** Unrestricted installation on company servers is permitted for internal deployment, automated document generation, and asset management systems.

3. BRANDING AND CLIENT DELIVERABLES

- **Full Rights:** Use in logotypes, corporate identities, packaging, and global marketing campaigns is fully included without geographic restriction.
- **Third Parties (Agencies):** While you may not distribute the font file publicly, you may provide the Font to external agencies, printers, or developers working on your behalf, provided they agree to use the Font exclusively for your projects and delete it upon completion.

4. UNLIMITED BROADCASTING & DIGITAL USE

This license removes the metric restrictions of lower-tier licenses and grants full broadcasting rights:

- **Broadcasting & Streaming (The “TV” Right):** Unlimited worldwide rights for use in traditional Television (National/Global), Cinema, and commercial content for Streaming Platforms (Netflix, Amazon Prime, HBO, etc.), regardless of budget or audience size.
- **Digital Advertising:** Unlimited use in all forms of digital and social media advertising.
- **Web Use:** Unlimited monthly pageviews on unlimited domains owned by the Licensee.
- **Apps & eBooks:** Unlimited embedding in multiple Mobile Applications and Electronic Books owned by the Licensee.

5. THE ONLY RESTRICTIONS (OEM / SAAS)

While this license covers all internal and output uses of the Licensee, it does **NOT** cover uses where the Font Software itself is the product being sold to third parties (OEM). The following require a separate OEM Agreement:

- **SaaS Platforms:** You may not embed the Font in a web-based design tool (e.g., website builders, template editors) where your customers select the font to create their own designs.
- **Hardware Embedding:** You may not embed the Font in hardware devices (printers, appliances, smart screens) for resale.
- **Retail Products:** You may not sell alphabet-based physical products (stamps, stencils, adhesive letters) where the letterform is the primary value.

6. MODIFICATIONS (DERIVATIVE WORKS)

You may convert the Font Software into vector outlines (e.g., in Adobe Illustrator) and modify those outlines for logo design purposes. However, you are strictly prohibited from modifying, adapting, decompiling, or reverse engineering the Font Software file itself (.otf, .woff2) to create a derivative font product or to bypass embedding restrictions.

7. WARRANTY AND LIMITATION OF LIABILITY

7.1. Limited Warranty

The Font Software is provided **“AS IS”**. Eurotypo warrants only that the Font Software will perform substantially in accordance with the documentation for a period of thirty (30) days from the date of purchase. If the Font Software is defective, your sole and exclusive remedy will be, at Eurotypo's option, either the replacement of the Font Software or the refund of the license fee.

7.2. Disclaimer of Consequential Damages

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL EUROTYP0 BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, PUNITIVE, OR CONSEQUENTIAL DAMAGES WHATSOEVER. THIS EXPLICITLY INCLUDES, WITHOUT LIMITATION, DAMAGES FOR:

- LOSS OF BUSINESS PROFITS OR REVENUE.
- LOSS OF AUDIENCE OR MARKET SHARE.
- DAMAGE TO BRAND PRESTIGE, REPUTATION, OR GOODWILL.
- BUSINESS INTERRUPTION OR WORK STOPPAGE.
- LOSS OF DATA OR COMPUTER FAILURE.

EVEN IF EUROTYPYPO HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, THE FOUNDRY'S TOTAL LIABILITY UNDER ANY PROVISION OF THIS AGREEMENT SHALL BE STRICTLY LIMITED TO THE AMOUNT ACTUALLY PAID BY THE LICENSEE FOR THE FONT SOFTWARE.

8. TERMINATION

This license is effective until terminated. Eurotypo has the right to terminate your license immediately if you fail to comply with any term of this Agreement. Upon termination, you must destroy the original and any copies of the Font Software and cease all use of the trademarks.

9. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of Spain. Any dispute arising from or in connection with this Agreement shall be subject to the exclusive jurisdiction of the Courts of Valencia, Spain. The United Nations Convention on Contracts for the International Sale of Goods is specifically excluded.
