

End User License Agreement

(EULA) – Standard License (Level 1)

Please read this agreement carefully before installing the Font Software.

1. GRANT OF LICENSE

Eurotypo (hereinafter “Licensor”) grants the purchaser (hereinafter “Licensee”) a non-exclusive, perpetual, non-transferable, and worldwide license to install and use the Font Software (hereinafter “the Font”) subject to the strict terms and conditions set forth in this agreement.

By downloading or installing the Font, you acknowledge that you have read, understood, and agreed to be bound by the terms of this agreement. You are purchasing the right to use the Font (a license), not ownership of the design or the copyright.

2. PERMITTED USERS AND DEVICES

- **User Limit:** This license covers a maximum of **1 User (CPU)**.
- **Installation:** The authorized user may install the Font on up to two (2) devices (e.g., a desktop computer and a laptop), provided that such devices are owned by the Licensee and are not used simultaneously.
- **Server Use:** Installation on network servers accessible by multiple unlicensed users is strictly prohibited.

3. BRANDING, LOGOTYPES, AND CLIENT DELIVERABLES

You are fully authorized to use the Font to design logotypes, corporate identities, and marketing materials. However, the delivery of files to third parties is strictly regulated:

- **PERMITTED (Vector Outlines):** You may deliver the final design (logo or artwork) to your client in static formats (JPG, PNG) or as vectorized outlines (PDF, EPS, AI) where the text has been converted to paths/curves. Your client does not need an additional license to use these graphic files.
- **PROHIBITED (Font Files):** You may **NOT** send, transfer, sublicense, or gift the Font installation file (.otf, .woff2) to your client, printer, or any third party.
- **Client Obligation:** If your client wishes to install the Font on their own computers to edit text, create new designs, or use it on their website, they must purchase their own license appropriate for their needs.

4. WEB AND SOCIAL MEDIA USE

- **Webfont Self-Hosting:** You are permitted to embed the Font in one (1) website using the provided webfont files (.woff2) via the '@font-face' technology, hosted on the Licensee's server.
- **Traffic Limit:** Up to **100,000 monthly pageviews**. If your traffic exceeds this limit for three consecutive months, you must upgrade to a Studio License (Level 2).
- **Social Media:** Unlimited use is permitted for images and short video clips on social media platforms (Instagram, TikTok, YouTube, LinkedIn), provided the content does not constitute broadcast television advertising.

5. KEY EXCLUSIONS (NOT INCLUDED)

This Standard License is designed for general desktop and promotional use. The following uses require an upgrade to a Studio (Level 2) or Corporate (Level 3) license:

- **Apps and eBooks:** Embedding the Font in mobile applications (iOS/Android), desktop software, or electronic books (ePub) is **NOT** permitted.
- **Broadcasting:** Use in television, cinema, streaming services (Netflix, HBO, etc.), or high-budget broadcast advertising is **NOT** permitted.
- **Commercial Products (OEM/Alphabet):** You may **NOT** use the Font to create physical or digital products where individual letterforms are the primary commodity for sale (e.g., stencil kits, letter stamps, alphabet stickers, editable templates).

6. MODIFICATIONS (DERIVATIVE WORKS)

You may convert the Font Software into vector outlines (e.g., in Adobe Illustrator) and modify those outlines for use in logos or designs. However, you are strictly prohibited from modifying, adapting, decompiling, or reverse engineering the Font Software file itself (.otf, .woff2) to create a derivative font product or to bypass embedding restrictions.

7. WARRANTY AND LIMITATION OF LIABILITY

7.1. Limited Warranty

The Font Software is provided **"AS IS"**. Eurotypo warrants only that the Font Software will perform substantially in accordance with the documentation for a period of thirty (30) days from the date of purchase. If the Font Software is defective, your sole and exclusive remedy will be, at Eurotypo's option, either the replacement of the Font Software or the refund of the license fee.

7.2. Disclaimer of Consequential Damages

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL EUROTYPY BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, PUNITIVE, OR CONSEQUENTIAL DAMAGES WHATSOEVER. THIS EXPLICITLY INCLUDES, WITHOUT LIMITATION, DAMAGES FOR:

- LOSS OF BUSINESS PROFITS OR REVENUE.
- LOSS OF AUDIENCE OR MARKET SHARE.
- DAMAGE TO BRAND PRESTIGE, REPUTATION, OR GOODWILL.
- BUSINESS INTERRUPTION OR WORK STOPPAGE.
- LOSS OF DATA OR COMPUTER FAILURE.

EVEN IF EUROTYPY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, THE FOUNDRY'S TOTAL LIABILITY UNDER ANY PROVISION OF THIS AGREEMENT SHALL BE STRICTLY LIMITED TO THE AMOUNT ACTUALLY PAID BY THE LICENSEE FOR THE FONT SOFTWARE.

8. TERMINATION

This license is effective until terminated. Eurotypo has the right to terminate your license immediately if you fail to comply with any term of this Agreement. Upon termination, you must destroy the original and any copies of the Font Software and cease all use of the trademarks.

9. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of Spain. Any dispute arising from or in connection with this Agreement shall be subject to the exclusive jurisdiction of the Courts of Valencia, Spain. The United Nations Convention on Contracts for the International Sale of Goods is specifically excluded.
